### AUDITS.

Will be Exposed and trained in Auditing of Unlisted Companies right from Transaction verification till finalisation of Audit, involving all the applicable acts like Companies act, Direct and Indirect Taxes act, Labour laws, Auditing / Accounting Standards in the three years of Article ship.

Will also be trained in preparation and filing of various Forms in Compliance with Companies Act,2013 in the MCA Portal and this will expose them to the various sections of the Companies act,2013 and to gain good understanding and grip of the Companies act,2013 to face final exams and help them in professional career building.

#### **DIRECT TAX**

Exposure in Income tax matters of unlisted Companies, partnership firms, Individuals, salary and Trust. Will be Trained in conducting Tax Audit of Corporates and Non-Corporates. Computation of Income statements of Companies, Firms, Individuals, Trust and salary cases. various Capital gains computation, Drafting of reply to scrutiny assessments, application of various income Tax sections practically, so that in the final year of Article ship, they will gain expertise in all areas practically, which will help them to confront both exams and employment with ease.

#### INDIRECT TAX

Will be exposed in GST Act application to every business / Professional entity in the course of conducting Statutory audits / Tax audits. Reconciliation and preparation of GSTR 9 and 9C Forms and various other forms under the GST Act.

TWO Months study leave will be permitted for first attempt and from succeeding attempt onwards, ONE-month leave is permitted

- a) During the **SEASONAL** period from **JUNE TO DEC.**-Articled students would work for **SIX** days from 10 AM TO 5.30PM.
- b) During NON-SEASONAL Period from JAN TO MAY Articled students would work for FIVE days -Monday to Friday in a week from 10AM to 5 PM. This would enable them to study and plan for their classes comfortably during this period.
